

# **End-User License Agreement**

Welcome to explore our licences and EULA!
We understand that dealing with legal documents isn't the most exciting part of your creative journey, but we've done our best to keep ours straightforward and easy to understand.

What is our approach? Our licenses come with extensive usage rights right from the start, meaning fewer exceptions and keeping things simple for you. We offer three types of licenses: Desktop, Web, and App, designed to fit a variety of uses.

We reserve the right to update this EULA as needed. Therefore, it is advisable to review it to ensure it meets your needs each time you make a purchase. And if you have any questions or need clarification, don't hesitate to reach out.

# **Our licences**

### **Desktop License**

Our Desktop License grants you the right to install and use the Font Software on a specified number of computers (CPUs) within your organization. This license allows you to create static documents and graphics such as brochures, posters, books, logos, logotypes, wordmarks, retail products, merchandise, and other printed materials. Within the scope of this Desktop License, you are also permitted to use the specified Font Software in social media posts, videos and digital banners. However, there are two exceptions: you are not permitted to include Fonts in documents (e.g., PDFs) that are intended for further editing, and you are prohibited from creating or selling products or gifts for commercial distribution that solely showcase the letterforms of our Fonts or include alphabet products as standalone elements.

#### Web License

A Web License allows you to embed the Font Software in WOFF and/or WOFF2 format on your website using the @font-face rule in CSS. This license is based on the number of page views your website receives. Redistribution, modification, or embedding the Font Software in any other web-based or server-based application, or in any other file format (e.g., OTF), is prohibited. The Fonts must be hosted on a web server under your control and must not be made available for download or extraction by end users. If you require the Fonts to be used across multiple domains, each domain must have its own Web License.

#### **App License**

An App License grants you the right to embed the Font Software in mobile or desktop applications distributed via app stores or other distribution platforms. This license is based on the number of application installations or downloads. Redistribution, modification, or using the Font Software in other applications or for any other purpose is prohibited. The Font Software must be embedded in such a way that it cannot be extracted or used by end users outside of the application. Each application or title must have its own App License.

# **Full EULA**

This EULA (End-User License Agreement) takes effect and forms a binding legal agreement between VantoFonts and you upon the ordering and installation of the Fonts.

#### **Grant of License**

We grant you a non-exclusive, non-transferable license to use the Fonts in accordance with this Agreement. You are not allowed to modify, alter, edit or enhance the Fonts or the Font Software. Distribution, sale, lending, lease, licensing, sublicensing, or offering the Fonts to any third party is prohibited. You are allowed to create a reasonable number of backup copies of the Font Software exclusively for your own archival purposes. This License is perpetual and all rights not explicitly granted in this EULA are reserved to us.

# Rights reserved

The Fonts are licensed, not sold, to you by VantoFonts. VantoFonts retains all rights, title, and interest in and to the Fonts, including all intellectual property rights such as copyright, trademark, and trade secret rights. You acknowledge that no ownership rights are transferred to you under this Agreement and that this Agreement does not grant you any rights to use VantoFonts' trade names, trademarks, service marks, logos, domain names, or other distinctive brand features. You may not modify, adapt, or create derivative works of the Fonts including, but not limited to, the metadata in the Font Software.

#### Permitted use

The permitted uses of the Font Software are detailed in the individual licenses (Desktop, Web and App) provided with each type of Font Software. These licenses specify the scope and manner in which you may use the Fonts. The precise permissions and restrictions will vary based on the type of license you purchase. Any use of the Font Software not expressly permitted by the individual license agreements is strictly prohibited and all rights not explicitly granted are reserved to us.

# **Refund policy**

All sales of the Fonts are final, and no refunds will be issued. In the event that a faulty font is supplied or the Font presentation does not match the supplied Font(s), you must notify us within 30 days of purchase, detailing the nature of the defect. Upon receiving your notification, we will do our best to correct a possible defect and re-supply the Font file(s). VantoFonts' obligation to correct defects and re-supply a modified Font(s) is the sole remedy available to you for any issues related to faulty fonts. Under no circumstances will we be liable for any damages, including incidental or consequential damages, arising from the use or inability to use the Fonts.

#### **Disclaimer of Warranties**

We strive to produce high-quality fonts. If you encounter any issues with the Fonts, please contact us and we will do our best to resolve the issue through appropriate measures. However, VantoFonts provides the Fonts "as is", without any warranties of any kind.

# **Limitation of Liability**

We will not be liable for any failure or delay in performance due to causes beyond our reasonable control, including but not limited to failures of internet service providers. # **Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of Finland, without regard to its conflict of law principles. Any dispute, controversy, or claim arising out of or relating to this Agreement, or the breach, termination, or validity thereof, shall be finally settled by the court of Helsinki, Finland.

# **Complete Agreement**

You acknowledge that you have read this Agreement, understand it, and agree to be bound by its terms and conditions. By purchasing, downloading, installing, or otherwise using the Font Software, you signify your assent to this Agreement. If you do not agree to the terms of this Agreement, you are not authorized to use the Font Software.

# **Test Fonts**

We offer test versions of our fonts ("Test Fonts") to allow you to evaluate and test them before making a purchase. Tese Fonts are identified with the word "Test" in the font name. These Test Fonts come with a limited glyph set and are intended solely for your personal and internal evaluation purposes. You may not use Trial Fonts for any commercial projects or public use. The Rights, Warrantied and Limitation of Liability that apply to our full version Fonts also extend to our Trial Fonts. If you wish to use the fonts beyond the limitations of this Test Fonts license, you must purchase a full license that grants you the appropriate rights for commercial use and public display, as outlined in our Desktop, Web, and App Licenses.
